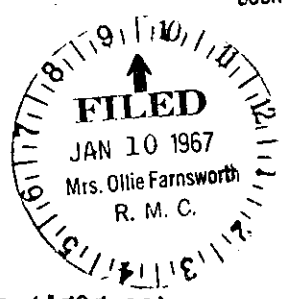

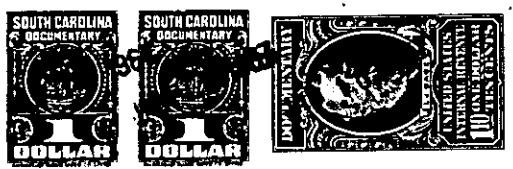
KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore,

in consideration of - - Five Hundred Eighty-five and No/100 (\$585.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ralph B. Turner, Jr. and Mary H. Turner, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated just below the town of Piedmont, South Carolina, being known and designated as Lot No. 41, of a subdivision known as Monticello Estates, as shown by a Plat thereof, by Woodward Engineering Co. dated March 1956, and recorded in the R. M. C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following description, to-wit:

BEGINNING on West Monticello Road at an iron pin at joint front corners of lots 40 and 41 and running thence 80 feet with the line of said Road to an iron pin at joint front corners of lots 41 and 42; running thence 215.6 feet with the side line of lot 42 to an iron pin at joint rear corners of lots 41, 42, 29 and 30; running thence 80.2 feet with the rear line of lot 30 to an iron pin at joint rear corners of lots 30, 31, 40 & 41; running thence 221.5 feet with the side line of lot 40 to the iron pin at joint front corners of lots 40 and 41 on W. Monticello Drive, the point of beginning.



NO residence to cost less than \$5,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 40 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance subject to all easements and rights of way of record. GRANTEE to pay taxes for year 19 67.
