William C. Henderson, his Heirs and Assigns forever:

ALL that certain tracts of land, with the improvements thereon, situated in the City of Greenville, State of South Carolina, known and designated as Tract "A" containing 6.2 acres and Tract "D" containing .5 acres in accordance with plat made for Grantor, recorded in the R.M.C. Office for Greenville County in Plat Book XX, at Page 198, and being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin in the center of Henderson Drive at the western edge of Grantor's property and the adjoining property of Lilly Mae Henderson and running thence along William C. Henderson line N. 5-30 E. 942 feet to iron pin; thence S. 79-58 W. 300 feet to iron pin; thence S. 6-43 W. 884.4 feet to iron pin in center of Henderson Drive; thence along Henderson Drive S. 79-55 E. 104.5 feet to iron pin; thence N. 85-40 E. 208.7 feet to iron pin, being the point of beginning.

ALSO: BEGINNING at an iron pin in the center of Henderson Drive at the western edge of Grantor's property, said line joining the Gower Estate property, and running thence along the Gower Estate property S. 19-50 E. 275 feet to iron pin; thence S. 72-04 E. 100 feet to iron pin; thence N. 19-50 W. 275 feet to iron pin; thence N. 72-04 W. 100 feet to iron pin, being the point of beginning.
