the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles V. Hannon and Roxie S. Hannon, their heirs and assigns,

All my right, title and interest, being a one-sixth interest, in and to:

All those lots of land in the County of Greenville, State of South Carolina, on the northern side of East Faris Road, in the City of Greenville, being Lots Nos. 10, 12 and one-half of Lot 14 as shown on a plat of a Subdivision of the Goddard-McPherson Property, made May 11, 1938, and revised April 16, 1959, and described as follows:

BEGINNING at an iron pin on the northern side of East Faris Road, 372.8 feet east from Augusta Street, at the corner of Lot 8, and running thence with the northern side of East Faris Road, N. 63-45 E. 127.5 feet to iron pin in the center of Lot 14; thence through the center of said lot N. 26-14 W. 156.1 feet to iron pin in line of Lot 9; thence with lines of Lots 9 and 7, S. 55-55 W. 128.75 feet to iron pin at corner of Lot 8; thence with line of said lot S. 26-14 E. 138.9 feet to the beginning corner.
