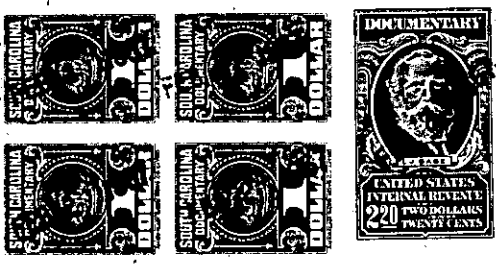
ROBERT BAILEY, HIS HEIRS AND ASSIGNS, FOREVER:
