All that piece, parcel or lot of land with buildings and improvements thereon situate, lying and being on the west side of Scarlett Street, near the City of Greenville, Greenville County, State of South Carolina, being shown as lot No. 219 on plat of Sherwood Forest made by Dalton & Neves, Engrs. August 1951 revised through June 1953, and recorded in the RMC office for Greenville County in Plat Book GG, at Pages 70 and 71. This being the same property conveyed to Gordon L. Sisk and Bertha B. Sisk by Ralph Weller as shown by deed recorded in Deed Book 586, at Page 407, RMC office for Greenville County.

ALSO: All that other piece, parcel or lot of land in the County of Greenville, in Gantt Township, State of South Carolina near the City of Greenville and being South of Old Anderson Road (Dunham Bridge Road), and according to a survey made by Piedmont Engineering Service on November 5, 1949, having the following metes and bounds:

BEGINNING at a point on the Eastern side of Security Drive, 444 feet South from the Southeast intersection of Security Drive and Anderson Road and running thence S. 22-21 E. 5.6 feet to an iron pin; thence N. 71-43 E. 35 feet to an iron pin; thence S. 22-12 E. 191 feet to an iron pin; thence S. 51-0 W. 50 feet to an iron pin; thence S. 72-0 W. 519 feet; thence N. 9-26 W. 208.2 feet to an iron pin; thence N. 72-0 E. 472 Feet to an iron pin; in the center of Security Drive; thence N. 51-0 E. 1515 feet to the point of beginning. Being the same property conveyed to G.L. Sisk and Bertha B. Sisk by deed of Clyde L. Holcombe recorded in Deed Book 488, at Page 183.
