the limits of the City of Greenville, partially in Reedy River, and having the following
metes and bounds, to wit:

BEGINNING at a point in the 6600 foot radius City Limit Line of the City of Green-
ville, in the joint line of property conveyed to the grantee by Southeastern Broadcasting
Corporation, and running thence N. 82-46 E. 48 feet, more or less, to a point in Reedy River;
thence N. 24-24 W. 23.2 feet to a point in said river; thence N. 30-22 W. 20 feet, more or
less, to the said radius City Limit Line; thence with the said radius line of the City Limits
of the City of Greenville 52 feet more or less in a Southwesterly direction to the point of
beginning; being a very small portion of that property conveyed to the grantor by the deed
of Abney Mills recorded in the R. M. C. Office for Greenville County in Deed Book 809, at
