the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Glynn A. Lindsey, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 98 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Ridge Spring Street, joint front corner of Lots Nos. 54 and 98, and running thence along the southern edge of Ridge Spring Street, N. 85-36 E. 90 feet to an iron pin at the joint front corner of Lots Nos. 98 and 99; thence along the joint line of said lots, S. 4-24 E. 175 feet to an iron pin on the rear line of Lot No. 124; thence along the line of that lot, S. 85-36 W. 71 feet to an iron pin on the rear line of Lot No. 53; thence along the line of that lot, N. 10-14 W. 62.2 feet to an iron pin at the joint rear corner of Lots Nos. 53 and 54; thence along the rear line of Lot No. 54, N. 10-04 W. 113.5 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 648, page 169, and is also subject to such drainage and utility easements as appear of record.
