in consideration of ONE THOUSAND TWO HUNDRED and NO/100 (\$1,200.00----- Dollars,

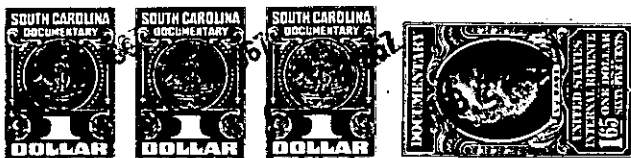

ALL THAT CERTAIN piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. Five (5) on a plat of PROPERTY OF J. R. WEST, surveyed by Thomas T. Linder, August 16, 1937, recorded in the RMC Office for Greenville County in Plat book "D", Page 268, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the west side of West Avenue, joint corner of Lots nos. 5 and 6, and running thence with line of Lot No. 6 S. 73-45 W. 180.5 feet to a stake; thence S. 14-45 E. 66 feet to a stake, joint corner of Lots Nos. 5 and 4; thence with line of Lot No. 4 N. 73-45 E. 182.5 feet to a stake on West Avenue; thence with West Avenue N. 16-15 W. 66 feet to the beginning corner.
