KNOW ALL MEN BY THESE PRESENTS, that we, Richard F. Watson, Jr. and Evelyn P. Watson,

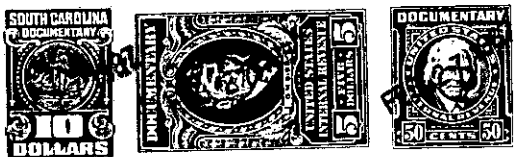
in consideration of Five Thousand and No/100-----(\$ 5,000.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Paul F. Haigler, Jr., his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 38 of a subdivision of the property of the grantors as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Paul F. Haigler, Jr." prepared by Piedmont Engineers and Architects January 31, 1967, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Darien Way, joint front corner of Lots Nos. 37 and 38, and running thence along the joint line of said lots, following the center of a 10-foot drainage easement, N. 13-50 E. 200.0 feet to an iron pin on the rear line of Lot No. 52; thence along the rear lines of Lots Nos. 52 and 50, N. 75-29 W. 201.9 feet to an iron pin at the joint rear corner of Lots Nos. 38 and 39; thence along the joint line of said lots, S. 13-15 W. 215.0 feet to an iron pin on the northern edge of Darien Way; thence along the northern edge of Darien Way, S. 79-46 E. 200.0 feet to the beginning corner.

This conveyance is subject to utilities easements of record and is also subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 690, Page 531 as amended by subsequent restrictions recorded in Deed Vol. 758, at Page 116.
