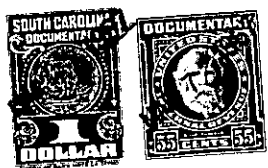

Bruce by Webb Surveying & Mapping Co. dated December 30, 1965, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book MMM at Page 135, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point, joint corner of Lots 24, 25, N and M, and running thence N. 45-48 E. 40.8 feet to a point in line of Lot B; thence turning and running S. 46-14 E. 61.6 feet to a point; thence continuing along the common boundary of Lots M and C S. 28-53 E. 67.1 feet to a point, joint corner of Lots M and L; thence turning and running S. 56-24 W. 45.5 feet to a point, joint corner of Lots M, L, 25 and 26; thence turning and running N. 18-34 W. 67.6 feet to a point; thence continuing N. 53-30 W. 57.8 feet to the point of beginning.
