KNOW ALL MEN BY THESE PRESENTS, that I, William L. Crain

in consideration of Ten (\$ 10.00) and love and affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

T. H. Crain, his heirs and assigns, all that piece, parcel or lot of land lying and being in Highland Township, Greenville County and State of South Carolina lying on the east side of State Highway number 114 which leads from Blue Ridge High School northward to State Highway No. 11, and having the following metes and bounds To Wit:

BEGINNING on a point in the center of said Highway Number 114 and running thence S. 65-00 E. 372 feet to an iron pin; thence N. 61-30 E. 200 feet to an iron pin; thence N. 13-30 W. 305.7 feet to an iron pin; thence S. 81-45 W. 64.8 feet to an iron pin; thence S. 65-00 E. 526 feet to a point in said Highway Number 114; thence down and with said Highway S. 12-45 E. 461.5 feet to a point in said road, the beginning corner and containing four and seventy-four one hundredths acres, more or less.

This tract is further described on a plat made by H. S. Brockman, Surveyor, from a survey made January 17-19, 1944.

This is the same tract of land conveyed to me by Deed by T. H. Crain, bearing date of February 10th 1966, and recorded in the Office of Register of Mesne Conveyance for Greenville County in Book 791 of Deeds, page 572.
