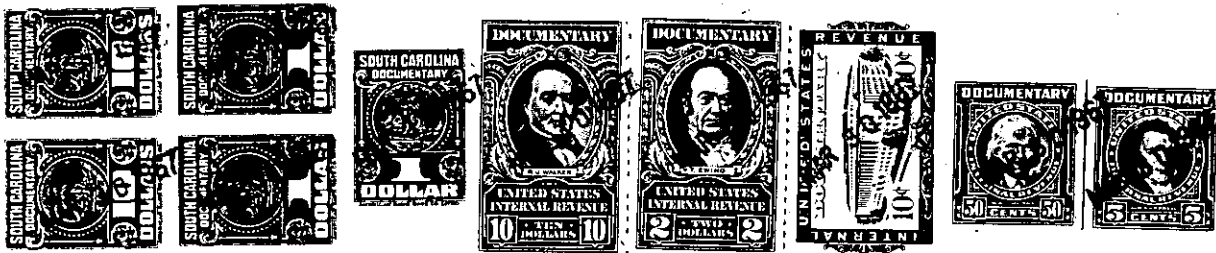
Eleven Thousand Two Hundred Fifty and No/100-----(\$11,250.00)---- Dollars,

ALL that lot of land with improvements lying on the Southern side of Alpha Drive in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 89 on a Plat of KENNEDY PARK made by Piedmont Engineers & Architects, dated September 28, 1964, revised on January 28, 1966, and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 179, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Alpha Drive at the joint front corners of Lots Nos. 89 and 90 and running thence S. 2-42 W., 133 feet along the common line of said lots to an iron pin; thence S. 87-18 E., 75 feet to an iron pin at the joint rear corners of Lots Nos. 89 and 88; thence running along the common line of said lots, N. 2-42 E., 133 feet to an iron pin on Alpha Drive; thence along the Southern side of Alpha Drive, S. 87-18 E., 75 feet to an iron pin, the beginning corner.
