unto Jack E. Shaw Builders, Inc., their successors and assigns, forever:

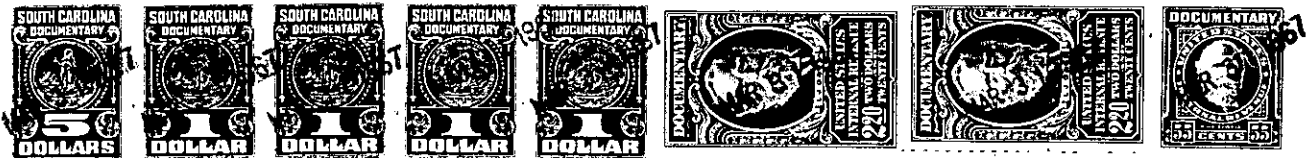
