ALL THAT piece, parcel or lot of land located in the County of Greenville, State of South Carolina, being shown and designated as Lot 51 on a plat of the PROPERTY OF ALVIN A. McCALL, JR., dated April 10, 1965, by C. O. Riddle, recorded in the RMC Office for Greenville County in Plat Book "M-11", at Page 42, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Howell Circle, joint front corner of Lots Nos. 51 and 52 and running thence along Howell Circle, N. 23-30 W. 111.4 feet to a point; thence running along the curve of Howell Circle, the chord of which is N. 20-27 E. 36 feet to a point on the southern side of Old Spartanburg Road; thence along Old Spartanburg Road N. 65-07 E. 173.6 feet to a point on the western side of an unnamed street; thence along said unnamed street 143.7 feet to an iron pin, joint rear corner of Lots Nos. 51 and 52; thence along joint line of Lots Nos. 51 and 52 S. 66-30 W. 223.6 feet to the point of beginning.
