the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edward H. Hembree, his heirs and assigns,

All that lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 104 on plat of Property of the Estate of Tully P. Babb, recorded in Plat Book QQ at Pages 162-163, in the RMC Office for Greenville County, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the western side of Stonehaven Drive, joint corner of Lots 104 and 105, and running thence with line of Lot 105, S. 89-55 W. 355.2 feet to iron pin; thence N. 9-08 W. 100 feet to iron pin; thence N. 5-25 W. 50 feet to iron pin at the joint rear corner of Lots 103 and 104; thence with line of Lot 103, N. 89-47 E. 389.8 feet to iron pin on Stonehaven Drive; thence with said Drive S. 5-22 W. 150 feet to the point of beginning.

This deed is made pursuant to authority granted to Emma L. Flinkingshelt, as Trustee, in deed recorded in Vol. 485 at Page 410, and by authority granted to the grantor, as will be seen in the will of the late Elizabeth H. Babb, who died testate on November 3, 1962 (see Apt. 807, File 16 in the office of the Probate Judge for Greenville County).

This property is conveyed subject to the following restrictions:

1. The property shall be used for single unit residential dwellings only.
2. No house shall be constructed on said lot containing less than 2200 square feet, exclusive of porches, carports and breezeways.

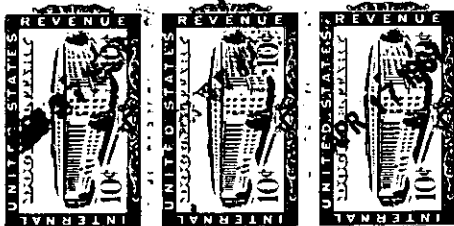
