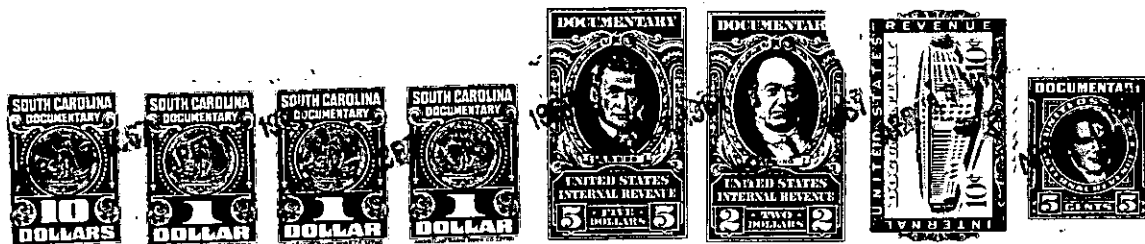
KNOW ALL MEN BY THESE PRESENTS, that I, H. D. Burns

ALL that piece, parcel or lot of land in Bates Township, Greenville County, S. C., on the western side of U. S. Highway No. 276 (Travelers Rest, Ceaser's Head Road,) the same being shown and designated as Lot #35 on a plat of the property of the "Nannie K. Hunt Estate," plat made by H. L. Dunahoo, Surveyor, dated Nov. 15 & 16, 1951 and recorded in Plat Book AA, Page 134, RMC Office for Greenville County, and having the courses and distances according to the above-mentioned plat which is incorporated herein by reference.
