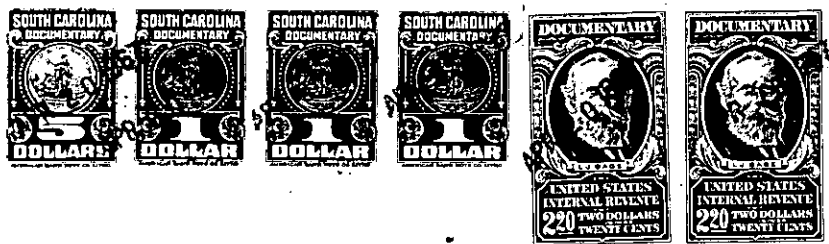
KNOW ALL MEN BY THESE PRESENTS, that we, Edward Nasser and LeRoy Nasser
