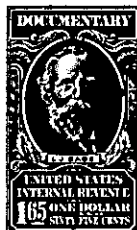

ALL THAT PIECE, PARCEL OR LOT OF LAND SITUATE, LYING AND BEING IN MAULDIN, GREENVILLE COUNTY, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT 1, ON A PLAT OF "ADDITION TO KNOLLWOOD HEIGHTS" DATED JUNE 2, 1966, AND REVISED APRIL 11, 1967, PREPARED BY PIEDMONT ENGINEERS AND ARCHITECTS AND HAVING, ACCORDING TO SAID PLAT THE FOLLOWING METES AND BOUNDS, TO-WIT:

BEGINNING AT A POINT ON THE NORTHWESTERN EDGE OF EDGEWOOD DRIVE AT THE JOINT FRONT CORNER OF LOTS 1 AND 2, AND RUNNING THENCE ALONG A LINE OF LOT 2, N. 47-27 W. 165 FEET TO A POINT; THENCE S. 39-21 W. 159.47 FEET TO A POINT ON THE NORTHEASTERN EDGE OF KNOLLWOOD DRIVE; THENCE ALONG THE NORTHEASTERN EDGE OF KNOLLWOOD DRIVE, S. 61-45 E. 85 FEET TO A POINT; THENCE CONTINUING ALONG THE NORTHEASTERN EDGE OF KNOLLWOOD DRIVE, S. 58-04 E. 50 FEET TO A POINT; THENCE ALONG THE EDGE OF THE CURVE OF THE NORTHEASTERN CORNER OF THE INTERSECTION OF KNOLLWOOD DRIVE AND EDGEWOOD DRIVE, THE CHORD OF WHICH IS N. 82-14 E. 38.5 FEET, TO A POINT ON THE NORTHWESTERN EDGE OF EDGEWOOD DRIVE; THENCE ALONG THE NORTHWESTERN EDGE OF EDGEWOOD DRIVE, N. 42-33 E. 99.4 FEET TO THE BEGINNING CORNER, AND BEING A PORTION OF THE PROPERTY CONVEYED BY MARY D.
