Sheriff a lot or parcel of ground in Graceland Cemetery, Greenville County, South Carolina, designated as Grave Space Nos. 1-2-3-4-5 & 6 in Lot No. 110, Section No. 5 containing 200 square feet, more or less, monument privileges, the same being described and designated as above, in accordance with map on file in the office of GRACELAND CEMETERY DEVELOPMENT CO., INC.

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all restrictions and limitations, Rules and Regulations of Graceland Cemetery now in force or which may hereafter be passed, relating to said Cemetery and the burial of the dead therein. This being the same property conveyed to the grantor by GRACELAND CEMETERY DEVELOPMENT CO., INC. by deed dated August 8, 1953 and recorded in the R. M. C. Office for Greenville County in Vol. 609 Page 213.
