All that certain lot of land lying in the State of South Carolina, County of Greenville, City of Greenville, on the eastern side of Seabrook Court shown as Lot #16 on a Plat of Section Two, Property of Elizabeth L. Marchant, recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 145 and being further described as follows:

BEGINNING at an iron pin on the eastern side of Seabrook Court at the joint front corner of Lot Numbers 16 and 17; running thence along the line of Lot No. 17 S 88-32 E. 250 feet to an iron pin at the corner of Lot No. 18; thence along the line of Lot No. 18 S 31-37 E 110 feet to an iron pin at the corner of Lot No. 15; thence along the line of Lot No. 15 S 81-01 W 271.5 feet to an iron pin on the eastern side of Seabrook Court; thence along Seabrook Court N. 30-22 W 65.3 feet; thence continuing along Seabrook Court N. 9-02 W. 59 feet to an iron pin; thence N 5-58 E. 25.7 feet to the beginning corner.
