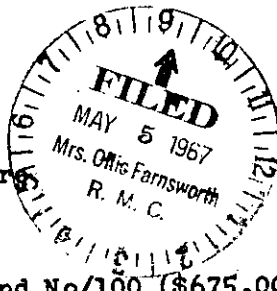

John W. Bristol and Ruth Bristol, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 51 as shown on a Plat of Lincoln Town made by Dalton & Neves, Engineers, dated June, 1945 and recorded in the R. M. C. Office for Greenville County in Plat Book S, at Page 39, and having according to said plat the following descriptions, to-wit:

Lot No. 51:

BEGINNING on Wynette Avenue at an iron pin at joint front corners of Lots 52 and 51 and running thence 40 feet with the line of Wynette Avenue to an iron pin at joint front corners of lots 51 and 50; running thence 150 feet with the side line of lot 50 to an iron pin at joint rear corners of lots 50, 51 and 42; running thence 40 feet with the rear line of lot 42 to an iron pin at joint rear corners of lots 42, 41, 52 and 51; running thence 150 feet with the side line of lot 52 to the iron pin at joint front corners of lots 52 and 51 on Wynette Avenue, the point of beginning.
