forever:

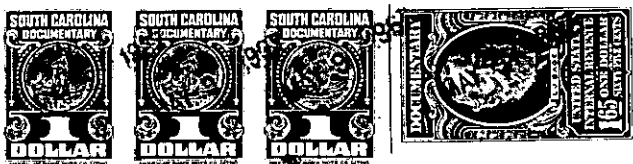
ALL that lot of land with improvements lying on the Northern side of Alpha Drive in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 123 on a Plat of KENNEDY PARK made by Piedmont Engineers & Architects, dated September 28, 1964, revised January 28, 1966, and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 179, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Alpha Drive at the joint front corners of Lots 123 and 124 and running thence N. 2-42 E., 133 feet to an iron pin; thence S. 87-18 E., 75 feet to an iron pin; thence along the common lines of Lots 123 and 124, S. 2-42 W., 133 feet to an iron pin on Alpha Drive; thence along the Northern side of Alpha Drive, N. 87-18 W., 75 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to rights of way and easements shown on the aforementioned recorded plat of Kennedy Park and appearing of public record otherwise and to restrictive covenants applicable to said subdivision recorded in the RMC Office for Greenville County, S. C., in Deed Book 773, page 527.

As a part of the consideration for this deed the Grantees agree and assume to pay in full the indebtedness due on a note and mortgage covering the above described property in favor of Anderson Savings & Loan Association, of Anderson, S. C., recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 1050, page 541, which has a present balance due in the sum of \$9,900.00, more or less.
