Tripp to Harold R. McGee and running thence along the western side of Gridley Street S. 13-20 W. 74.8 feet to an iron pin; thence N. 79-55 W. 100.4 feet to an iron pin; thence N. 13-20 E. 70 feet to an iron pin; thence S. 85-15 E. 101.6 feet to the point of beginning.

Riddle and having the following metes and bounds, to-wit: BEGINNING at an iron pin at the rear corner of lot No. 6 now or formerly belonging to May Frank Morrow (which pin is 50 feet S 13-20 W. from Ansel Street), and running thence S. 13-20 W. 50 feet to a stake; thence S. 85-15 E. 2 feet; thence S. 13-20 W. 15.9 feet; thence with the line of lot No. 4, S. 79-55 E. 50.6 feet to a stake at the corner of lot No. 3; thence with the rear line of lots Nos. 3 and 2 N. 13-20 E. 70 feet to a stake; corner of lot No. 6; thence with the line of lot No. 6, N. 85-15 W. 52.8 feet to the point of beginning.
