in the State aforesaid, in consideration of the sum of Nineteen Thousand Five Hundred and No/100 (\$19,500.00)----- DOLLARS,

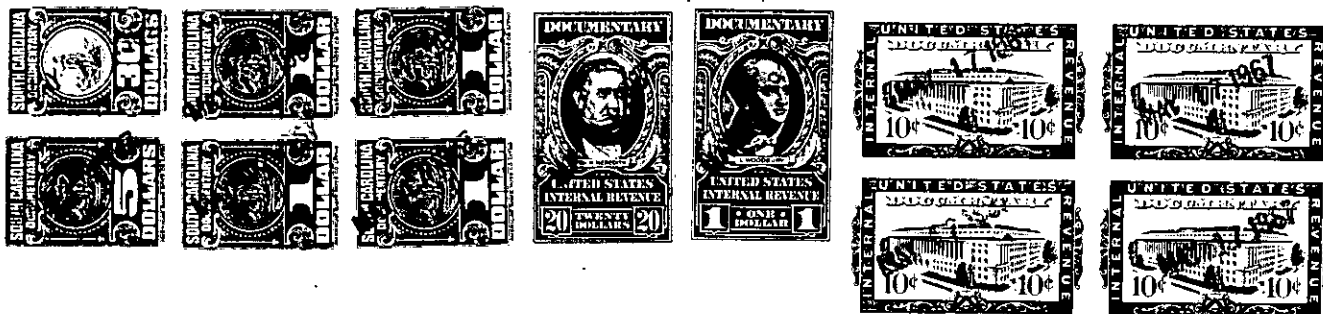
