the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

O. H. Ogle, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the northeastern side of Sheffield Lane and being known and designated as Lot No. 7 of Avon Park Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "KK", at Page 71 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Sheffield Lane, joint front corner of Lots Nos. 7 and 8 and running thence with the common line of said lots N. 15-53 E. 175 feet to an iron pin; thence across the rear line of Lot No. 7 N. 66-15 W. 91 feet to an iron pin; thence with the common line of Lots Nos. 6 and 7 S. 15-53 W. 175 feet to an iron pin on the northeastern side of Sheffield Lane; thence with said Lane S. 74-07 E. 90 feet to an iron pin, the point of beginning.
