the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles D. Howard and Irene S. Howard, their heirs and assigns:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 11 of a subdivision known as Montroyal Hills as shown on a plat thereof prepared by Piedmont Engineering Service, August, 1957, and recorded in the R.
