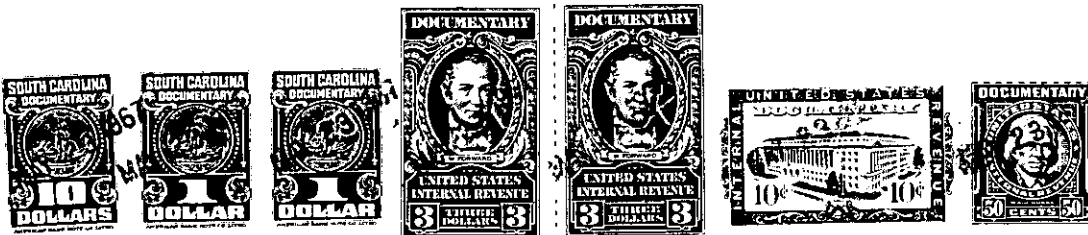

BEGINNING at an iron pin in the center of River Drive at the joint front corner of Lot Nos. 4 & 5 and running thence S 14 W 315 feet, more or less, to a point in the center of Middle Saluda River; thence down the River in an easterly direction approximately 175 feet to an iron pin at the corner of Lot 6; thence with it, N 6-30 W 329 feet to an iron pin in the center of River Drive; thence with the center of said Drive, S 83-30 W 20 feet to an iron pin; thence continuing with said Drive; thence N 61-30 W 50 feet to the point of beginning and being the same conveyed to me in Deed Book 650, page 154.
