in consideration of Six Hundred and 00/100 (\$600.00) - - - - - Dollars,

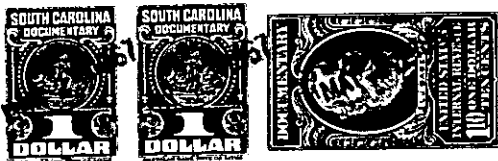
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

ALL that piece, parcel or lot of land lying, being and situate in the County and State aforesaid about 1 mile Northeast of the Town of Fountain Inn, in the subdivision known as Friendship Heights, known and designated as lot No. 24 in Block A. on a plat prepared by W. N. Willis, Engineers, May 30, 1960, and having the following metes and bounds, according to said plat, to-wit:
