R. Carl Moody, his heirs and assigns forever:

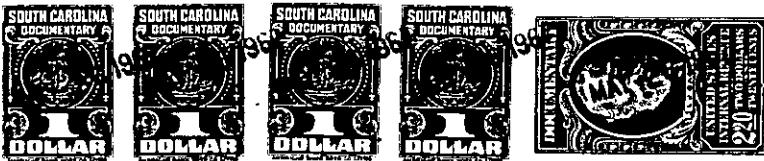

C. in Plat Book Page , and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Maria Louisa Lane, said pin being the joint front corner of Lots 3 and 4 and running thence with the common line of said Lots N 41-26 E 165.8 feet to an iron pin, joint rear corner of Lots 3 and 4; thence N 57-41 E 175 feet to an iron pin, joint corner of Lot 4 and property now or formerly belonging to H. O. Moody; thence S 50-11 W 221.3 feet to an iron pin, joint corner of Lot 4 to a iron pin in line of Lot No. 1 C. B. Jones property; thence N 57-31 W 100 feet to an iron pin on the southeasterly side of Maria Louisa Lane; thence with said Lane on a curve, the chord of which is N 3-12 W 57.3 feet to an iron pin, the point of beginning.
