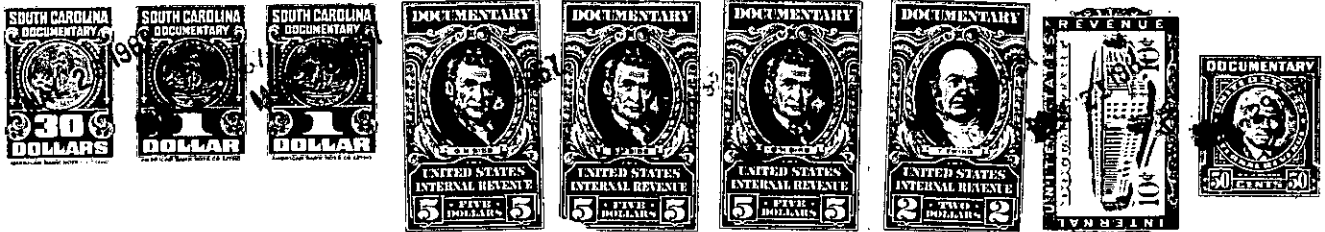
in consideration of Fifteen Thousand Five Hundred Twenty-five (\$15,525.00) Dollars,
