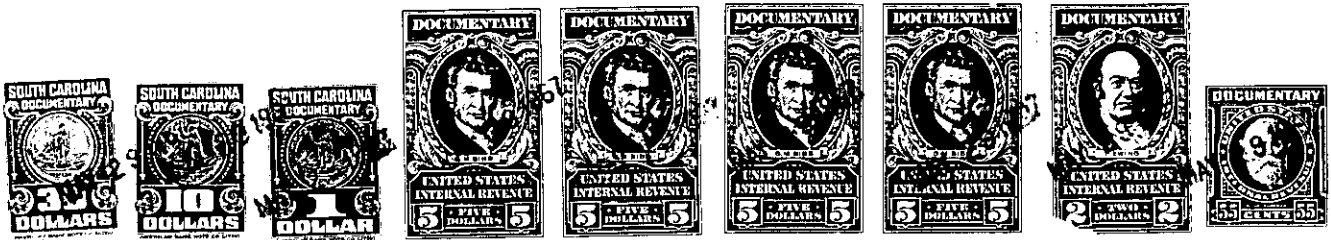
KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Donald C. Mock, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lots 2 and 3 of a subdivision known as Brookwood Forest, Section 3, as shown on plat thereof prepared by Webb Mapping and Surveying Co., Inc., dated December 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 156 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Charing Cross Road, joint front corner of Lots 1 and 2 and running thence along the joint line of said lots, S. 0-03 W. 155.5 feet to an iron pin; thence S. 86-33 E. 242.6 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence N. 19-46 E. 216.6 feet to an iron pin at the joint rear corner of Lots 3 and 4; thence along the joint line of said lots, N. 65-16 W. 187.6 feet to an iron pin on the southern edge of Charing Cross Road; thence following the curvature of Charing Cross Road, the chords being S. 45-03 W. 110 feet, S. 56-45 W. 50 feet and S. 77-15 W. 28 feet to the beginning corner; being the same conveyed to me by Mauldin Construction Co. by deed dated February 6, 1967, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 813, at Page 349.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
