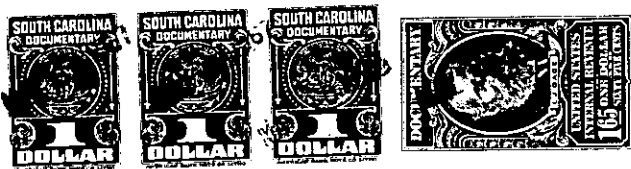
in consideration of One Thousand Ninety Five and No/100 -- (1,095.00) Dollars,
