KNOW ALL MEN BY THESE PRESENTS, that I, HATTIE B. HARMON,

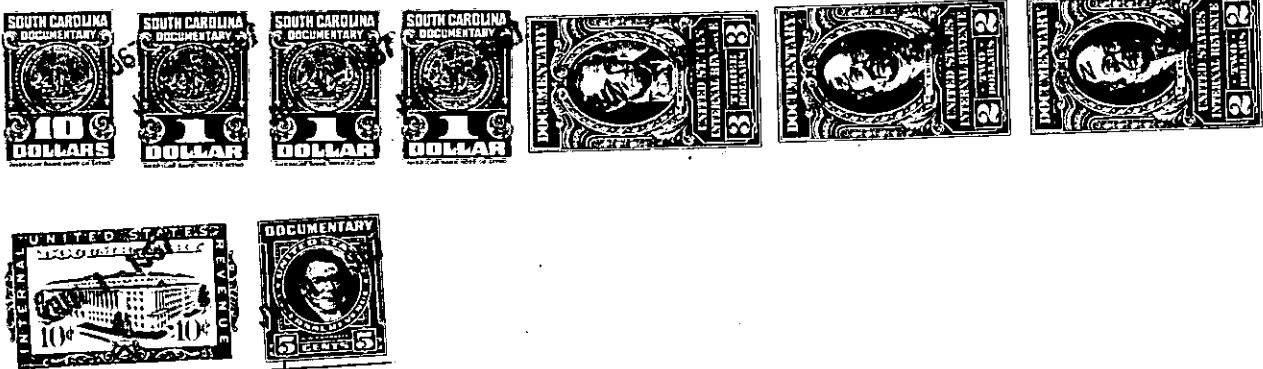
in consideration of Six Thousand Five Hundred and no/100 (\$6,500.00) Dollars,
