KNOW ALL MEN BY THESE PRESENTS, that I, Thomas M. Creech, of Greenville County

in consideration of Two Thousand and No/100 (\$2,000.00)-----Dollars,
and assumption of mortgage set out below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto
Johnny H. Taylor, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 94 according to a plat entitled "Plat No. 2, Sunset Hills", prepared by R. E. Dalton, Engineer, December 1945, recorded in the R. M. C. Office for Greenville County in Plat Book P, at Page 18, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Waccamaw Circle at the joint front corner of Lots Nos. 94 and 95 and running thence along the joint line of said lots, N. 48-50 E. 175 feet to an iron pin at the joint rear corner of Lots Nos. 94 and 95; thence along the rear line of Lot No. 94, N. 41-10 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 94 and 93; thence along the joint line of said lots, S. 48-50 W. 175 feet to an iron pin on the northern side of Waccamaw Circle, joint front corner of Lots Nos. 93 and 94; running thence along the northern side of said Waccamaw Circle, S. 41-10 E. 75 feet to the point of beginning; being the same conveyed to me by Douglas E. Burd by deed dated February 20, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 717 at Page 116.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed by Douglas E. Burd in the original sum of \$10,650.00 in favor of C. Douglas Wilson & Co., recorded in the R.M. C. Office for Greenville County in Mortgage Book 770 at Page 333, which mortgage has been assigned to the Metropolitan Life Insurance Company, on which there is a balance due of \$8,484.78 as of this date.
