KNOW ALL MEN BY THESE PRESENTS, that I, GRADY L. FOSTER

in consideration of TWENTY THOUSAND FIVE HUNDRED AND NO/100ths (\$20,500.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto EDWIN CURTIS HARTNEY, his heirs and assigns forever: MARY W. HARTNEY, her heirs and assigns forever:

ALL of that lot of land in the County of Greenville, State of South Carolina, in Paris Mountain Township, being composed of lot nos. 1, 4, 5, 6, 7, and the Reserved as shown on plat of Grady Foster made by J.C. Hill, recorded in Plat Book VV, page 59, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at or near the center of Manly Drive at the corner of property of Robert T. Ashmore and running thence along Manley Drive, S 59 W 100 feet to an iron pin; thence S 54-50 W 100 feet to an iron pin; thence S 48-05 W 100 feet to an ironpin; thence N 67-40 W 14 feet to a point in said street; thence S 53 W 2 feet to an iron pin in said street; thence S 37-20 W 123 feet, which iron pin is at or near the center of the curve of said street; thence S 63-50 E 94.5 feet to an iron pin; thence S 69-10 E 85.3 feet to an ironpin; thence S 83-30 E 68.4 feet to an iron pin; thence N 86 E 100 feet to an iron pin; thence N 68 E 158.3 feet to an iron pin; thence N 69 E 25 feet to an iron pin; thence N 68-35 E 50 feet to an iron pin; thence N 51-10 E 50 feet to an iron pin; thence N 40 E 25 feet to an iron pin; thence along the Ashmore property, N 55-10 W 345.2 feet to the point of beginning.

THIS is the balance of the property which was willed to me by Pauline W. Foster as will appear in Apartment 579, file 21. The northwesternmost portion comes out of the deed to her from William H.
