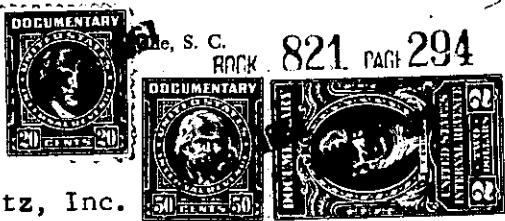

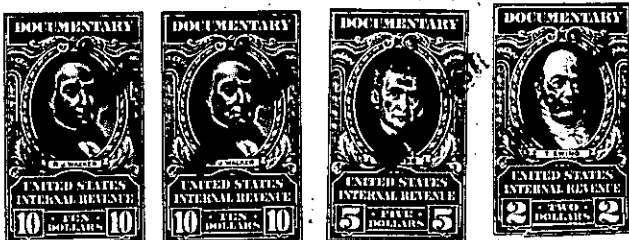
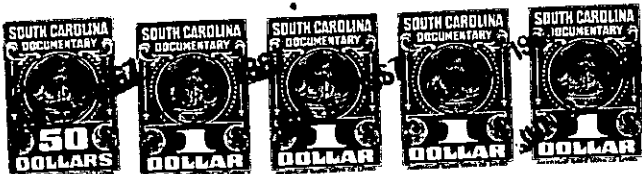

All that lot of land situate on the east side of Hialeah Road in the city of Greenville, in Greenville County, S. C., being shown as Lot No. 353 on plat of Section B of Gower Estates, made by R. K. Campbell, Surveyor, December 1961, and recorded in the RMC Office for Greenville County, S. C., in Plat book XX at pages 36 and 37, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Hialeah Road, at the joint front corner of Lots No. 352 and 353 and runs thence along the line of Lot 352, S. 69-48 E. 185.8 feet to an iron pin; thence S. 17-49 W. 75 feet to an iron pin; thence with the line of Lot 354, N. 77-25 W. 176.5 feet to an iron pin on the east side of Hialeah Road; thence with the curve of Hialeah Road (the chord being N. 12-08 E. 100 feet) to the beginning corner.

This is the same lot conveyed to grantor by Conyers & Gower, Inc. by deed recorded March 30, 1966 in vol. 795 page 157 of the RMC Office for Greenville County, S. C., and is conveyed subject to restrictions applicable to said subdivision recorded in deed book 693 page 7, and to any recorded easements or rights of way.
