complaint in the ~~Court of Common Pleas~~ for the County aforesaid, against
Douglas R. Miller, Jr., et al., etc.,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 27th day of May 1958,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, to Worthy B. Nabors, Jr. and Michael Allan Nabors,
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree Worthy B. Nabors, Jr. and Michael Allan Nabors,
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release

unto the said Worthy B. Nabors, Jr. and Michael Allan Nabors,
"All that piece, parcel and lot of land lying and being in Austin Town-
ship, Greenville County, South Carolina, on the Georgia Road about two mile
northeast of the Town of Simpsonville and being a portion of the 43.2 acre
tract of land referred to in Item XI of the Will of J. P. Hipps, deceased.
It is described in detail by courses and distances on plat made by H. S.
Brockman, Reg. Land Surveyor, dated April 23, 1958, which said plat is to be
recorded: Said lot begins on the southern edge of the Georgia Road at or
near the center of the line of the highway S- 160 and runs thence along the
said highway S-160 S. 36-15 E. 208.6 feet to corner in said highway; thence
N. 63-55 E. 223.7 feet to corner; thence N. 36-15 W. 208.7 feet to corner
on the southern edge of the Georgia Road; thence along that road S. 63-55 W
223.7 feet to beginning corner in Highway S-160 and containing one acre, more
or less, and being shown as Tract Number 3 on the Brockman plat which was
introduced in evidence.

This deed is executed and delivered by the Master, conveying the above
described property pursuant to the Order of Court and is without any mone-
tary consideration. For that reason, it is not necessary to place any re-
venue stamps on this deed.
