in consideration of Voluntary Partitiōn Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Inez H. Kennedy, Her Heirs and Assigns,

ALL OF OUR RIGHT, TITLE AND INTEREST IN AND TO:

ALL that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, being Tract 5, containing 6.22 Acres, more or less, on the Plat of the property of Richard A. Hill Estate, by T. H. Walker, Jr., dated April 29, 1967, noted in Plat Book 000, at Page 109, Office of the R. M. C. for Greenville County, being a part of the property described in Deed Book 96 at page 331, Office of the R. M. C. for Greenville County, and being more particularly described as follows:

BEGINNING at a point or iron pin in line of division of Tract No. 4 and Tract No. 5, and running thence N. 3-04 W. 108 feet to an iron pin; thence N. 11-34 E. 92 feet to a point or iron pin; thence along line of division of Tracts No. 5 and No. 6, N. 64-32 E. 980.76 feet to a stone and iron pin; thence S. 1-10 W. 417.8 feet to a point or iron pin at line of division of Tracts No. 4 and No. 5; thence S. 77-12 W. 911.55 feet to the point of beginning, being a 6.22 Acre Tract.

THIS Deed is pursuant to a Voluntary Partition in Kind by the heirs at Law of Richard A. Hill, who died intestate in Greenville County on August 20, 1965, owning property in Greenville as shown in Apartment 965, File 3, leaving as his sole heirs at law, six children, namely, Julius G. Hill, Sylvester Hill, Aleain Hallums, Picola Hill, Inez H. Kennedy and Roy D. Hill, the said heirs have voluntarily agreed to a Partition in Kind, as evidenced by a Plat of the property of the Richard A. Hill Estate near Mauldin, South Carolina, by T. H. Waiker, Jr., Reg. L. S., dated April 29, 1967, recorded in Plat Book 000 at Page 109, Office of the R. M. C. for Greenville County.
