and assumption of mortgage referred to below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

William L. Meyer, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the eastern side of Scarlett Street (formerly Forest Green Road) and being known and designated as Lot No. 252 in a subdivision known as Sherwood Forest as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", Pages 70 and 71 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Scarlett Street, joint front corner of Lots Nos. 251 and 252 and running thence along the common line of said lots S. 76-44 E. 165 feet to an iron pin; thence across the rear line of Lot No. 252 S. 12-50 W. 75 feet to an iron pin, joint rear corner of Lots Nos. 252 and 253; thence with the common line of Lot No. 253 N. 76-44 W. 165.6 feet to an iron pin on the eastern side of Scarlett Street; thence with the eastern side of Scarlett Street N. 13-16 E. 75 feet to an iron pin, the point of beginning.
