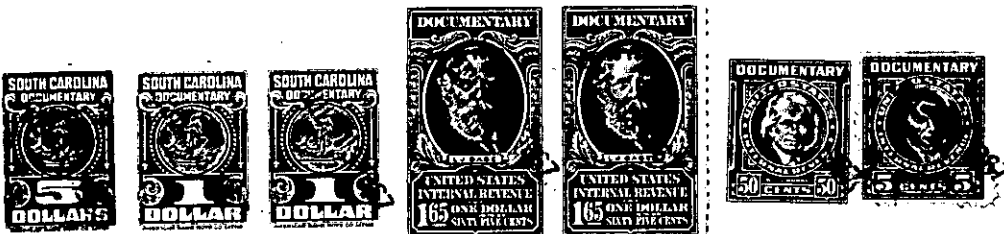
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents o grant, bargain, sell and release unto the said Aspasia Talfeff, their heirs and assigns forever:

All of that certain parcel or lots of land situated on the North side of Endless Drive, about one (1) mile northward from city of Greer, in Chick Springs Township, Greenville County, State of South Carolina, and being all of Lots Nos. EIGHT (8) and NINE (9) of the property of W. Dennis Smith, according to a survey and plat by H. S. Brockman, Registered Surveyor, dated Dec. 29, 1956 and recorded in Plat Book 00 pages 4 and 5, R. M. C. Office for Greenville County and having the following metes and bounds, to wit:
