KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County

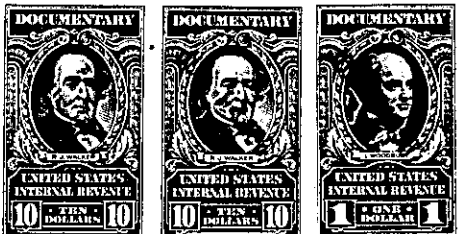
in consideration of Nineteen Thousand, Five Hundred and No/100 (\$19,500.00)-----Dollars,

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 141 of a subdivision known as Avon Park as shown on a plat thereof prepared by C. C. Jones & Associates, dated November 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK at Page 71 and having the following metes and bounds, to-wit:
