

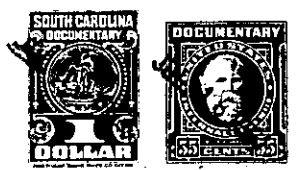
State of South Carolina TITLE TO REAL ESTATE

Lister hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his Heirs and Assigns,

All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, shown and designated as Lot F on a plat of property prepared for Dan E. Bruce by Webb Surveying & Mapping Co. dated December 30, 1965, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book MMM at Page 135, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point, joint corner of Lots 24, 25, E and F, and running thence S. 50-57 W. 83.25 feet to a point in line of Lot K; thence turning and running S. 28-53 E. 91.4 feet to a point in line of Lot H; thence turning and running N. 50-57 E. 100 feet to a point; thence turning and running along the common boundary of Lots 25 and F N. 39-03 W. 90 feet to the point of beginning.
