in consideration of and the assumption of mortgage set out below acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release W. Henry Martin, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 4 of a subdivision known as Belmont Heights as shown on plat thereof prepared by C. C. Jones and Associates and recorded in the R. M. C. Office for Greenville County in Plat Book GG at Pages 54 and 55, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Augusta Road, at the corner of Lot No. 3; thence along the line of that lot, N. 31-52 E. 183.5 feet to an iron pin on the southwest side of a 40-foot access road, now known as Saad Lane; thence along said 40-foot access road, N. 56-32 W. 80 feet to an iron pin at the rear corner of Lot No. 5; thence along the line of that lot, S. 41-20 W. 181.3 feet to an iron pin on the northeast side of Augusta Road; thence along the northeast side of Augusta Road, S. 54-38 E. 110 feet to an iron pin, the beginning corner; less, however, the easement for highway purposes which was taken in condemnation by the South Carolina State Highway Department; being the same conveyed to us by William Nelms and Oka Lee H. Nelms by deed dated June 17, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 725, at Page 344.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed by the grantors on the 25th day of May, 1965 in the original sum of \$ 15,300.00, in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. Office for Greenville County in Mortgage Book 996. at Page 93, on which there is a balance due of \$ 14,368.04.
