ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 12, on Plat of Property of J. BEGINNING at an iron pin on the northwestern side of Oakview Drive, joint corner of Lots 11 and 12, which pin is 220 feet in a sougwestern direction from the southwestern intersection of Oakview Drive and Augusta Drive East and running thence N. 67-57 W. 168.2 feet to an iron pin; thence S. 21-35 W. 60 feet to an iron pin; thence S. 67-57 E. 167.7 feet to an iron pin on the northwestern side of Oakview Drive; thence with the northwestern side of Oakview Drive, N. 22-03 E. 60 feet to an iron pin, the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record, on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the Grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co., on which there is a balance due of \$ 6,815.14 ; said mortgage being recorded in Mortgages Volume 638 at page 491.
