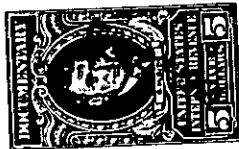
KNOW ALL MEN BY THESE PRESENTS, that we, Julian L. Wade, Jr., and Martha Ann E. Wade,

in consideration of Twenty-Five Thousand and No/100 (\$25,000.00)-----Dollars

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. J. Winter, his heirs and assigns forever;

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina, at the intersection of Boxwood Lane and Woodland Way and being known and designated as Lot No. 6 of Boxwood Manor, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 85, and having, according to a more recent plat made by Piedmont Engineering Service, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the northwestern side of Woodland Way at the joint front corners of Lots No. 5 and No. 6 of said subdivision and running thence along the common line of said lots N. 29-08 W. 250 feet to an iron pin; thence along the common line of Lots No. 6 and No. 18 S. 60-52 W. 100 feet to an iron pin on the eastern side of Boxwood Lane; thence along the eastern side of Boxwood Lane S. 29-08 E. 200 feet to a point; thence following the curve of Boxwood Lane as it converges with Woodland Way, the chord of which curve runs S. 74-08 E. 70.7 feet to a point on the northwestern side of Woodland Way; thence along the northwestern side of Woodland Way N. 60-52 E. 50 feet to an iron pin, the beginning corner; being the same property conveyed to the Grantor herein by Ellison S. McKissick, Jr., by Deed dated February 28, 1958, and recorded in the R. M. C. Office for Greenville County in Deed Book 593, at Page 537.
