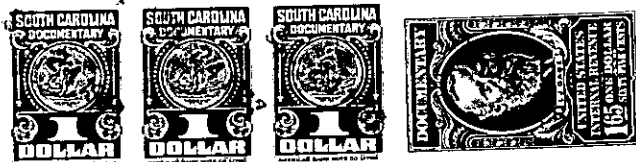
HENRY P. WILLIMON, his heirs and assigns forever,
