unto Blanche C. Carr, her heirs and assigns forever;

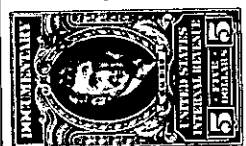

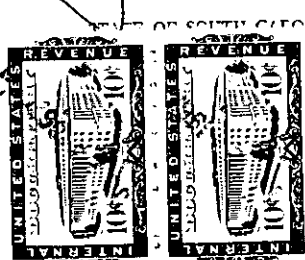
