C., being shown as Lot 128 on plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 181, and having, according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Pinefield Drive, at joint front corner of Lots 127 and 128, and runs thence with the line of Lot 127, N. 84-40 E. 124.6 feet to an iron pin; thence N. 5-20 W. 139.7 feet to an iron pin on the south side of Fairfield Road; thence along Fairfield Road S. 61-32 W. 119 feet to an iron pin; thence with the curve of Fairfield Road and Pinefield Drive. (the chord being S. 28-06 W. 27.5 feet) to an iron pin on the east side of Pinefield Drive; thence along Pinefield Drive, S. 5-20 E. 70 feet to the beginning corner.
