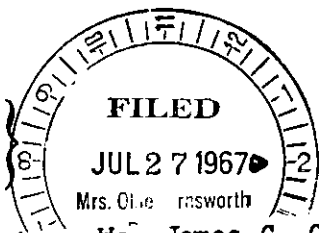

**J. B. Hewins, his heirs and assigns, forever:**

**ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as Lot No. 81, as shown on a Plat of Brookwood, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said Plat the following metes and bounds, to-wit:**

**BEGINNING at an iron pin on the southern side of Gantt Drive at the joint front corner of Lots 80 and 81 and running thence with the line of Lot 80, S. 2-15 W. 165 feet to an iron pin; thence along the rear line of Lot 54, S. 87-45 E. 100 feet to an iron pin joint rear corner of Lots 82 and 81; thence with the line of Lot 82, N. 2-15 E. 165 feet to an iron pin on southern side of Gantt Drive; thence with said Drive, N. 87-45 W. 100 feet to point of beginning.**
