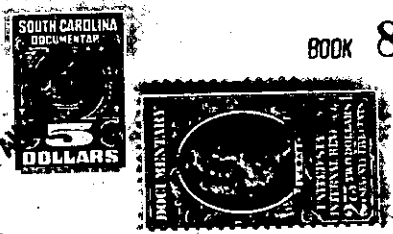

KNOW ALL MEN BY THESE PRESENTS, that I, Robert F. Compton

in consideration of Two Thousand Five Hundred and no/100 (\$2,500.00) and assumption Dollars, of below mentioned mortgage - - - - - the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Claude W. Blakely, his heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the northeastern side of Crestline Road, near the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot No. Twenty One (21) of Section A on plat of HILLANDALE HEIGHTS made by T. M. Welborn, Surveyor, October 7, 1950, recorded in the R.M.C. Office of Greenville County, S. C., in Plat Book "Y" at Page 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Crestline Road at the joint front corner of Lots No. 20 and 21, Section A, and running thence with line of Lot No. 20 N 41-36 E 238.7 feet to an iron pin; thence running S 64-42 E 140.5 feet to an iron pin; thence with line of Lot No. 29, Section B, S 53-43 W 294.2 feet to an iron pin on the northeastern side of Crestline Road; thence running with the northeastern side of Crestline Road N 41-24 W 79.5 feet to the beginning corner.

This being the same property as was conveyed to the grantor herein by deed of Nelson Norfleet Harte, Jr. as was recorded in the R.M.C. Office of Greenville County, South Carolina in Deed Book 691 at Page 29, January 23, 1962.

As part of the purchase price, Grantee assumes and agrees to pay the balance due in the amount of Seventeen Thousand Three Hundred Fifty-four and 17/100 (\$17,354.17) Dollars on that mortgage given by Grantor to Canal Insurance Company on January 23, 1962 and recorded in the R.M.C. Office for Greenville County, South Carolina in Real Estate Mortgage Book 880 at Page 3.

This property is shown on the Greenville County Auditor's Block Book as 448-2-24.

This property is conveyed subject to restrictions applicable to Hillandale Heights which are of record in the R.M.C. Office of Greenville County, South Carolina, in Deed Book 434, at Page 263.
